1. Target market for this product

Target Market

The retail clients for whom this product has been designed are individuals who:

- want a term loan to finance or refinance the acquisition of residential property for the purpose of it being used as a residential investment;
- want to pay only interest for a specified period at the start of their loan (up to 5 years), after which they want to
 pay principal and interest for the remaining term (maximum total loan term is 30 years)
- want flexibility to make additional repayments and have access to those early repayments;
- may want access to other features and benefits (such as linked offset account);
- · can afford the loan; and
- · can provide the residential property as security for the loan

Product Description

A Residential Investment Interest Only Home Loan (Variable Rate) is a variable interest rate term loan (up to a maximum term of 30 years) which is used to finance or refinance the acquisition of a residential investment property. Retail clients only have to pay interest charges for an initial period (up to 5 years) after which they then have to pay principal and interest for the remainder of the loan term. This home loan allows retail clients to make additional repayments without incurring early repayment costs and the ability to access those repayments. Retail clients can also access other features.

Product key attributes

The key attributes of this product that make it likely to be consistent with the target market described above, include:
